Rules of Requirements for English Proficiency of Undergraduate Students of Department of International Media and Entertainment Management at I-Shou University

Adopted by the University Academic Council on Dec. 18th, 2023, and promulgated with the consent from the President dated Feb. 22nd, 2024

- I. Legal Basis: The Rules of Requirements for English Proficiency of Undergraduate Students of Department of International Media and Entertainment Management at I-Shou University (hereinafter referred to as "the Rules") are made by the Department of International Media and Entertainment Management (hereinafter referred to as the "Department") pursuant to Article 5 of the Regulations for Graduation Requirements for Basic Competences of Students of I-Shou University.
- II. Purpose: The Rules are made with the aim of cooperating on the internationalization policy by the Ministry of Education and enhancing students' English proficiency in order to equip them with a competitive edge for further education and future careers.
- III. Scope of Application: All undergraduate students of the Department (including transfer students).

IV. Assessment Criteria:

V. Implementation:

- 1. During the prescribed duration of study, students of the Program shall not only earn the required number of credits but also fulfill the criteria of English Proficiency specified above to be eligible for graduation.
- 2. Students who fulfill the criteria of English proficiency specified above shall submit an application form and a valid test report to the Program office for review before the end of the second semester of their junior year. After the application has been approved, the non-credit-bearing course on "English Proficiency" will be registered as "Passed." Students who pass this course by submitting a valid test report are not required to register for such a course. Students who have passed the non-credit-bearing course by submitting a valid test report do not need to register for the course.
- 3. The English proficiency tests and the passing criteria adopted by the Program correspond to Level B2 under the Common European Framework (CEF). The aforesaid tests include GEPT, TOEFL, TOEIC, IELTS, NETPAW, Cambridge Main Suite, BULATS, and Linguaskill Business/ Linguaskill General.

VI. Measures for Failure to Fulfill the Criteria:

Students who do not pass any of the English proficiency tests specified in the attachment are required to take a makeup course on "English Proficiency", which is exclusively offered to junior and senior students by the Department / Program of the International College during the summer or winter vacation. The tuition for the course shall be the same as that for summer courses. Once a student passes the evaluation test after completing the course, their score for "English Proficiency" will be registered as "Passed." After being admitted to the University, students who have taken one of the designated English proficiency tests once every academic year and have taken three times or more in total are eligible to receive half of the credit fees of the course once only as a subsidy.

VII. The Rules become effective on the third day of promulgation after being adopted by the University Academic Council and ratified by the President.

Note: In case of any disputes or misunderstandings regarding the interpretation of the language or terms of the Rules, the Chinese language version shall prevail.
